VILLAGE OF EAGLE

January 22, 2019

The Village Board of Trustees met in regular session at 7:00 p.m. on January 22, 2019 with Moore, Meier, Schukei, Surman and Lahmon present. The Agenda items listed thereon were sufficiently descriptive to give the public reasonable notice of the matters to be considered at the meeting. The Chairperson, at the beginning of the meeting, informed the public about the location of the posted current copy of the Open Meetings Act. Chairperson Moore named the three (3) areas where the agenda was posted as follows: Eagle Municipal Building, Eagle Fire & Rescue Department and Eagle State Bank.

Chairperson Moore opened the public hearing at 7:00 p.m. concerning the One & Six-Year Street Improvement Plan for the Village of Eagle. Justin Stark (Olsson) provided a summary of the 2019-2024 One & Six-Year Street Improvement Plan. The One Year Street Improvement Plan for 2019 consists of general maintenance and three projects consisting of approximately four blocks of street paving. The Village's share of the total estimate for these projects is \$751,000. The remaining three projects on the Six Year Street Improvement Plan for 2019-2024 consist of approximately five blocks of street paving. The Village's share of the total estimate for these projects is \$728,000. The total estimated cost of all projects is \$1,479,000. Stark provided a location map and breakdown of the individual projects. Moore asked if there were any comments or questions from the public. There were no questions or comments from the board or public.

The public hearing was closed at 7:06 p.m.

AN ORDINANCE OF THE VILLAGE OF EAGLE, CASS COUNTY, NEBRASKA, TO AMEND THE OFFICIAL ZONING MAP OF THE VILLAGE OF EAGLE, NEBRASKA, PERTAINING TO THE FOLLOWING-DESCRIBED REAL ESTATE, TO WIT: LOT 1 OF EAGLE NURSERY, A SUBDIVISION LOCATED IN THE NORTH HALF OF THE SOUTHWEST QUARTER OF SECTION 28, TOWNSHIP 10 NORTH, RANGE 9 EAST OF THE 6TH P.M. Motion by Surman, second by Lahmon, to approve Trevor Herter as a member of the Eagle Fire & Rescue Department. Voting: Ayes – 5. Motion carried.

Open Forum – Dan Meier reported a problem with residents blowing snow from their property onto the streets. Moore will follow up with the Cass County Sheriff's Department to make them aware of the situation. Terry Caddy (21319 Holdrege St.) asked that the board take time to review the latest revision of the Comprehensive Development Plan and associated maps. Moore said the Steering Committee for the Comprehensive Development Plan will meet after tonight's meeting.

Motion by Lahmon, second by Schukei, to approve bid from Custom Cooling & Heating to replace gas valves, ignitor and filters in maintenance shop at a cost of \$1,290.65. Voting: Ayes – 5. Motion carried.

Motion by Lahmon, second by Schukei, to approve the installation of a street light at 2nd & A Street by OPPD in the amount of \$8.30 per month. Voting: Ayes – 5. Motion carried.

Motion by Lahmon, second by Surman, to approve installation of radios by the Electronic Repair Shop for use with existing camera system at the WWTP in the amount of \$1,137.00 and installed within 30-days weather permitting. Voting: Ayes – 5. Motion carried.

Motion by Lahmon, second by Schukei, to approve minutes as typed for the previous meeting. Voting: Ayes – 5. Motion carried.
