**WHEREAS**, a Hazard Mitigation Plan was prepared by the Lower Platte South Natural Resources District, with assistance from JEO Consulting Group, Inc. of Lincoln, Nebraska; and,

**WHEREAS**, the purpose of the mitigation plan was to lessen the effects of disasters by increasing the disaster resistance of the region and participating jurisdictions located within the planning boundary by identifying the hazards that affect the Village of Eagle and prioritize mitigation strategies to reduce potential loss of life and property damage from those hazards; and.

WHEREAS, FEMA regulations require documentation that the plan has been formally adopted by the governing body of the Village of Eagle in the form of a resolution and further requesting approval of the plan at the Federal Level; and,

**NOW, THEREFORE, BE IT RESOLVED**, that the Village Board of Trustees of the Village of Eagle, Nebraska, does herewith adopt the most recent and FEMA-approved version of the Lower Platte South NRD Hazard Mitigation Plan Update in its entirety.

#### VILLAGE OF EAGLE

#### October 20, 2025

The Village Board of Trustees met in regular session at 7:00 p.m. on October 20, 2025 with Todd, Hochstein, Meier and Surman present. Dobbins was absent. The Agenda items listed thereon were sufficiently descriptive to give the public reasonable notice of the matters to be considered at the meeting. The Chairperson, at the beginning of the meeting, informed the public about the location of the posted current copy of the Open Meetings Act. Chairperson Todd named the three (3) areas where the agenda was posted as follows: Eagle Municipal Building, Eagle Fire & Rescue Department and Eagle Municipal Park. The Pledge of Allegiance was recited.

Chairperson Todd opened the public hearing at 7:01 p.m. for the purpose of hearing testimony concerning the proposed passage of a Resolution of Necessity regarding the formation of Storm Sewer District No. 2025-1 for the of constructing proposed improvements to the Village storm sewer system. Todd asked if there were any comments or questions from the public. Trisha Morse (355 Wenzel Cir.) inquired as to the purpose of creating the Storm Sewer District. Brad Slaughter (Northland) said it is a statutory requirement in order for the Village to issue general obligation bonds for this project.

The public hearing was closed at 7:02 p.m.

Chairperson Todd opened the public hearing at 7:03 p.m. for the purpose of hearing testimony concerning an amendment to Section 4.19 of the Eagle Subdivision Regulations as the same relates to Design Standards of the Sanitary Sewer System. Nystrom said the Eagle Planning Commission recommended this change at its September 18, 2025 meeting. The Village Engineer also recommended this change from the standpoint of improved safety, ease of installation, better compaction, and consistency with regional standards. Todd asked if there were any comments or questions from the public. There were no comments or questions from the public.

The public hearing was closed at 7:04 p.m.

#### **RESOLUTION NO. 2025-08**

#### RESOLUTION OF NECESSITY

BE IT RESOLVED BY THE CHAIRPERSON AND BOARD OF TRUSTEES OF THE VILLAGE OF EAGLE, NEBRASKA:

- **Section 1**. The Chairperson and Board of Trustees (the "**Board**") deem and declare it advisable and necessary to construct improvements to the existing storm sewer system of the Village, including the extension of such system South on 2<sup>nd</sup> Street from A Street to B Street, West on B Street from 2<sup>nd</sup> Street to 4<sup>th</sup> Street, South on 4<sup>th</sup> Street from B Street to C Street and West on F Street from 5<sup>th</sup> Street to 100' West of 6<sup>th</sup> Street, by installing a 30" storm sewer pipe. The Board further finds that said improvements will constitute a general public improvement within said Village which may properly be financed by the issuance of general obligation bonds of said Village.
- **Section 2**. The storm sewer improvements described herein shall be constructed in accordance with the plans and specifications prepared by the engineers for the Village. Reference is hereby made to said plans and specifications, which plans, specifications and estimate of cost have been filed with the Village Clerk and are hereby approved and adopted.
- **Section 3**. For the purpose of constructing the proposed improvements there is hereby created in the Village a storm sewer district to be known and designated as Storm Sewer District No. 2025-1, the outer boundaries of which coincide with and are the same as the outer boundaries of the Village.
- **Section 4**. To pay the cost of the improvements herein provided for, the Board shall have the power, after such improvements have been completed and accepted by the Village, to cause to be issued the negotiable bonds of the Village to be called 'Storm Sewer Bonds'. All of the said improvements are declared to be general public improvements and not local improvements and for the benefit of all the property in the Village alike; and all of said improvements are found and declared to be necessary and proper to furnish a storm sewer system for said Village.
  - **Section 5**. The special engineers' estimate of the cost is \$1,300,000.
- **Section 6**. A hearing on this Resolution was held in the Village Fire Hall located at 705 S. 1st Street, Eagle, Nebraska during a meeting held on October 20, 2025 commencing 7:00 p.m. The Clerk is directed to publish notice of said hearing in the *Voice News*, or such other legal newspaper of general circulation in the Village, the weeks of October 6 and 13, 2025 (or such other days as determined in accordance with Section 17-914, Reissue Revised Statutes of Nebraska, as amended).

Brad Slaughter (Northland) said it is a statutory requirement in order for the Village to issue general obligation bonds for this project.

The Village Engineer also recommended this change from the standpoint of improved safety, ease of installation, better compaction, and consistency with regional standards. #### RESOLUTION OF NECESSITY

The Chairperson and Board of Trustees (the "**Board**") deem and declare it advisable and necessary to construct improvements to the existing storm sewer system of the Village, including the extension of such system South on 2<sup>nd</sup> Street from A Street to B Street, West on B Street from 2<sup>nd</sup> Street to 4<sup>th</sup> Street, South on 4<sup>th</sup> Street from B Street to C Street and West on F Street from 5<sup>th</sup> Street to 100' West of 6<sup>th</sup> Street, by installing a 30" storm sewer pipe. For the purpose of constructing the proposed improvements there is hereby created in the Village a storm sewer district to be known and designated as Storm Sewer District No. 2025-1, the outer boundaries of which coincide with and are the same as the outer boundaries of the Village.
- **Section 4**. To pay the cost of the improvements herein provided for, the Board shall have the power, after such improvements have been completed and accepted by the Village, to cause to be issued the negotiable bonds of the Village to be called 'Storm Sewer Bonds'. All of the said improvements are declared to be general public improvements and not local improvements and for the benefit of all the property in the Village alike; and all of said improvements are found and declared to be necessary and proper to furnish a storm sewer system for said Village.
  - **Section 5**. The special engineers' estimate of the cost is \$1,300,000.

Design Standards for sanitary sewers shall conform to Nebraska Department of Environment and Energy's Standards. Additionally, sanitary sewer service stubs must extend to a point no deeper than five feet (5') below the existing ground service.

WHEREAS, Daniel & Annette Manley are the owners of the parcel located in the following described real property: Tax Lot 38 located in the Northwest Quarter of Section 19, Township 10 North, Range 9 East of the 6<sup>th</sup> P.M., Cass County, Nebraska, and,

WHEREAS, a request was submitted that the Chair and Board of Trustees of the Village of Eagle, Nebraska, amend the Official Zoning Map of the Village of Eagle, Nebraska, to change the zoning upon the above-described real estate to Residential Estates (RE).

WHEREAS, said Village of Eagle Planning Commission did submit in writing its recommendations as to said zoning change, after public hearing, and,

WHEREAS, a notice of said change of zoning was posted upon the above described real estate such that it was easily visible from the street nearest said real estate, said notice having been posted at least ten (10) days prior to the date of this hearing, and,

WHEREAS, the Chair and Board of Trustees of the Village of Eagle, Nebraska, have conducted a public hearing regarding said change of zoning and received evidence thereat,

NOW, THEREFORE, BE IT ORDAINED BY THE CHAIR AND BOARD OF TRUSTEES OF THE VILLAGE OF EAGLE, NEBRASKA, AS FOLLOWS:

- 1. That the findings here and above made should be, and are hereby made a part of this Ordinance as fully as if set out at length herein.
- 2. That the Official Zoning Map of the Village of Eagle, Nebraska, be amended, as to the following-described real estate, to wit:

Tax Lot 38 located in the Northwest Quarter of Section 19, Township 10 North, Range 9 East of the 6<sup>th</sup> P.M. Cass County, Nebraska from:

Agricultural (AG) to Residential Estates (RE)

- 3. That the Chair and the appropriate Department, whether one or more, of the Village of Eagle, Nebraska, are hereby authorized and directed to implement this Ordinance including the indication on the Official Zoning Map of the Village of Eagle, Nebraska, as to the first above described real estate of this Change of Zoning.
- 4. Report from Fire & Rescue – Makinsey Lonergan (Rescue Captain) reported 8 rescue calls, 4 fire calls, 1 car accident, and 2 hazardous material calls since the September 15, 2025 board meeting. The training in October was on forcible entry (Fire) and high performance CPR (Rescue). The new EMS Medical Director Agreement with Dr. Noah Bernhardson was signed and submitted to the State of Nebraska. Officer elections will be held next month but there are no positions running opposed from last year.

Discuss/possible action: Updates on the new Fire & Rescue Station Facility - Luke Renken (Eagle-Alvo Rural Fire Board) shared the latest exterior drawings of the new facility as provided by Architectural Design Associates (ADA). His goal is to have 100% drawings by the end of next week and have the project out to bid in November. Renken noted some areas of bad soil on the construction site where the building will sit but feels this work can be done by a general contractor. Nystrom said the Village Board will consider two items tonight relating to this project; an Interlocal Agreement between the Village of Eagle and Eagle-Alvo Rural Fire Protection District No. 9 and the lot division location and contracting services for an administrative subdivision. The Rural Fire Board approved the Interlocal Agreement last week. Renken said his recommendation is to divide the lot right down the middle of the existing entrance; this will ensure access for all entities involved and adequate space for new parking stalls north of the facility. Surman said this would result in the linear footage being greater on the south lot where the new facility will be located. Renken said part of that is taken into consideration when you look at how much the south lot is being valued at as part of the agreement and bond payments; the entire lot and existing building was purchased for \$375,000; we are now valuing the south lot alone (with no structures) at \$800,000 as part of this deal. Surman said there will be another entrance into the south lot once the new curb cut exists south of the existing entrance. Renken said the second entrance does not protect the parking stalls north of the new facility; if the north lot ever sells in the future, there would be no access to those parking stalls, especially if a fence were to be erected. Surman discussed what would happen if G Street were extended through the middle of the lots in the future. Hochstein said there are instances of semi-trucks delivering products to the Village of Eagle; however, he feels if this becomes a problem in the future, some of the northeast fence line can be removed to provide additional access space. Nystrom said he contacted Jeff Daharsh (Cornerstone Surveying) who informed him the cost of an administrative subdivision at this particular location will likely cost between \$1,400-\$1,800.

Motion by Todd, second by Meier, to approve the lot division as presented and contracting services for an administrative subdivision as discussed. Voting: Ayes – 4. Motion carried.

Motion by Todd, second by Meier, to approve the Interlocal Agreement between the Village of Eagle and Eagle-Alvo Rural Fire Protection District No. 9. Voting: Ayes – 4. Motion carried.

Discuss/possible action: Consider change in Keno Operator from EHPV Lottery Services (Bid Red Keno) to Daily Double Keno Outlets, Inc. - Scott Zeilinger was present on behalf of Daily Double Keno Outlets. Todd, Meier and Nystrom recently met with Mr. Zeilinger and Ty McIntosh (Bailey's Local) about the possibility of making a change in the Village's Keno Operator. Zeilinger gave an overview of his company with the following highlights; The Village would receive a guaranteed 9% of Keno gross sales; Bailey's Local would receive a guaranteed 7% of Keno gross sales; and an estimated 1% of Keno gross sales would go to a Prize Reserve Fund. Daily Double Keno currently operates in communities such as Adams, Denton, Gretna, Hickman, Murdock, and Roca. Nystrom said the Village Attorney was made aware of this potential change and stated that it would be simpler to pass a resolution that sets forth that the Village will not extend the current interlocal agreement beyond the current termination date, if that is the route the Village Board wishes to take. The current agreement with Big Red Keno has an end date of May 14, 2026. The Village Board generally agreed to direct the Village Clerk to draft a resolution to consider a change in Keno Operator from Big Red Keno to Daily Double Keno Outlets. No further action taken.

WHEREAS, the Village Board of Trustees of the Village of Eagle, Nebraska, as the Village of Eagle's Governing Body, does desire to install a "Handicapped Parking Only" sign in order to identify a parking space reserved for individuals with mobility impairments at the following location which is located within the corporate limits of the Village of Eagle, Nebraska, to wit:

I. A "Handicapped Parking Only" sign located on the east side of 4<sup>th</sup> Street, approximately one hundred forty-three feet (143') north of F Street, adjacent to 632 S. 4<sup>th</sup> Street, valid twenty-four (24) hours per day.

NOW, THEREFORE, BE IT RESOLVED, by the Village Board of Trustees of the Village of Eagle, Nebraska, as follows:

Section 1. That the findings hereinabove made should be and are hereby made a part of this Resolution as fully as if set out at length herein.

Section 2. That traffic control devices, to wit: A "Handicapped Parking Only" sign, be erected on the east side of 4<sup>th</sup> Street, approximately one hundred forty-three feet (143') north of F Street, adjacent to 632 S. 4<sup>th</sup> Street, valid twenty-four (24) hours per day.

Section 3. That upon the approval of this Resolution, the aforenoted traffic control device shall be erected and this Resolution shall remain in full force and effect until further action by the Governing Body.

Motion by Hochstein, second by Surman, to adopt Resolution 2025-09. Voting: Ayes – 4. Motion carried.

Motion by Hochstein, second by Surman, to introduce Resolution 2025-10. Voting: Ayes – 4. Motion carried.

#### **RESOLUTION NO. 2025-10**

WHEREAS, the Governing Body of the Village of Eagle, Nebraska, has enacted a Municipal Code, and,

WHEREAS, Municipal Code §5-210 provides that the Board of Trustees may place stop signs, or other signs, signals, standards, or mechanical devices in any street or alley under the Municipality's jurisdiction for the purpose of regulating or prohibiting traffic thereon, by resolution, and,

WHEREAS, the Village Board of Trustees of the Village of Eagle, Nebraska, as the Village of Eagle's Governing Body, does desire to install a "Slow-Deaf Child Area" sign in order to increase driver awareness to the possibility of a child with hearing impairment in the area at the following locations which are located within the corporate limits of the Village of Eagle, Nebraska, to wit:

- I. A "Slow-Deaf Child Area" sign located on the east side of David Lane, approximately one hundred eighty-seven feet (187') north of F Street, adjacent to 600 David Lane, and,
- II. A "Slow-Deaf Child Area" sign located on the west side of David Lane, approximately one hundred six feet (106') south of Applewood Drive, adjacent to 425 David Lane.

NOW, THEREFORE, BE IT RESOLVED, by the Village Board of Trustees of the Village of Eagle, Nebraska, as follows:

Section 1. That the findings hereinabove made should be and are hereby made a part of this Resolution as fully as if set out at length herein.

Section 2. That traffic control devices, to wit: A "Slow-Deaf Child Area" sign located on the east side of David Lane, approximately one hundred eighty-seven feet (187') north of F Street, adjacent to 600 David Lane and a "Slow-Deaf Child Area" sign located on the west side of David Lane, approximately one hundred six feet (106') south of Applewood Drive, adjacent to 425 David Lane.

Section 3. That upon the approval of this Resolution, the aforenoted traffic control device shall be erected and this Resolution shall remain in full force and effect until further action by the Governing Body.

Discussion: Nystrom said he was contacted by a parent of a child with hearing impairment requesting the Village Board consider signage on each end of the street they reside on as an extra safety precaution for their daughter. Meier expressed concern that this type of signage may result in more people requesting personal signs for other causes. Todd inquired as to if there was any liability with providing the signs. Nystrom said from his research it was determined that these signs are not legally mandated or standardized. Meier expressed concern that people don't obey the current regulatory signs (stop, no parking signs, etc.) and cautioned installing more signage. Trisha Morse (355 Wenzel Cir.) encouraged the Village Board to approve the signage. Surman said he feels it is a good idea to at least attempt to make drivers aware of the possibility of a deaf child in the area that could run out into the street.

Motion by Todd, second by Surman, to adopt Resolution 2025-10. Voting: Ayes - 4. Motion carried.

Motion by Surman, second by Hochstein, to approve Riverstone Bank as the Village of Eagle depository. Voting: Ayes – 4. Motion carried.

Report on Streets and Maintenance – Terry Caddy reported that the public works department washed the chipper for the end of the season; the swimming pool is in the process of being filled for the winter; and the park restrooms will be closed for the season beginning October 27<sup>th</sup>. Todd asked if the warranty repairs were made to the pool steps. Caddy said no; the contractor will be contacted to determine if this will be a spring project. Meier said flat plastic drain covers need to be purchased prior to opening the

pool next year; the current drain covers interfere with the operation of the robotic vacuum cleaner. Caddy created a new maintenance manual for the generators and automobiles for the public works department to use on a regular basis. Caddy expressed interest in purchasing a display case for Village history items to be set up in the office lobby area; he would like to ensure that it would be covered by insurance since these items would be personal belongings. The Village Board generally agreed to allow a personal display case and history items in the office; the Village Clerk will check with insurance to determine if this is something that can be covered. Nystrom said orange notice tags will be hung on the front door of properties that still have brush piles at the curb after the deadline. Surman said the Street Committee and office staff met with the Village Engineer regarding the 4<sup>th</sup> Street and F Street reconstruction projects; a special meeting will be held prior to the projects commencing with specific invitations being sent to affected property owners so they have an opportunity to hear what the projects entail.

Report on Wells and Sewer – Caddy reported that the new water main which runs down Eagle Road is now live; the hydrants were flushed prior to opening the valves to the entire water system. He said pressure tests will be conducted on the hydrants as early as this week and reported a leak on the furthest west hydrant. Caddy said Cass County Rural Water invited representatives from Eagle to attend a meeting on November 6<sup>th</sup> at 10:00 a.m. in Weeping Water regarding the new City of Lincoln water main project.

Motion by Surman, second by Meier, to approve minutes as typed for the previous meeting. Voting: Ayes –Hochstein, Meier, Surman. Todd abstained. Motion carried.

Report from Committees and Boards – The Eagle Health Board discussed having a meeting on October 31st.

The meeting was adjourned at 8:34 p.m.
