

Village of Eagle Planning Commission Minutes January 23, 2019

The Village of Eagle Planning Commission meeting was called to order at 7:05 p.m. at the Eagle Fire & Rescue Department on January 23, 2019 by Chairman, Terry Caddy. It was indicated that the meeting notice was posted at the Village Office, Eagle State Bank, and the Fire Department. The Open Meetings Act was indicated as being on the east wall of the meeting room. Roll Call indicated four planning commission members present. Three guests were present.

The first item of business was the Public Hearing which was opened at 7:08 p.m. for the purpose of hearing testimony concerning the adoption of a new Comprehensive Development Plan for the Village of Eagle, Nebraska, including the 1.25 mile extraterritorial jurisdiction. The Chairman asked the two members of the Steering Committee which were present as guests, John Surman and Travis Moore to describe the change on the Future Land Use map which affects several properties east of 4th street and south of F Street changing the area from Commercial Future Land Use back to Residential Future Land Use as pointed out to the guests and Planning Commission Members using the previous and present Future Land Use Map to note the change.

Randy Cox, a guest attendee at the meeting asked several questions about the Commercial Future Land Use along 4th Street and present several observations which he had about the future of Eagle. The Public Hearing was adjourned at 7:21 p.m..

The second item of business was taken up at 7:21 p.m. which was to discuss the adoption of a new Comprehensive Development Plan for the Village of Eagle, Nebraska, including the 1.25 mile extraterritorial jurisdiction. Willa moved and Ty seconded the motion to move for the recommendation for approval for the adoption of a new Comprehensive Development Plan for the Village of Eagle, Nebraska, including the 1.25 mile extraterritorial jurisdiction.
